1. Gas Sales Volume

(1) Residential

The gas sales volume decreased from the previous year, due to higher temperatures in June which caused decrease of hot water demand, etc.

(2) Commercial, Public and Medical

The gas sales volume decreased from the previous year, due to lower temperatures in July which caused decrease of air-conditioning demand, etc.

(3) Industrial

The gas sales volume remained the same level as the previous year.

(4) Wholesale

The gas sales volume to other gas utilities decreased.
