(1)Residential

The gas sales volume increased from the previous year, due to lower temperatures in June and July which caused increase of hot water demand, etc.

(2) Commercial, Public and Medical

The gas sales volume decreased from the previous year, due to lower temperatures in June and July which caused decrease of air-conditioning demand, etc.

(3) Industrial

The gas sales volume decreased from the previous year, due to decrease in customer facilities' operation rates, etc.

(4)Wholesale

The gas sales volume to other gas utilities increased.
